- 1) Bill No. 3783 sponsored by Alderman Mark Dalton, being an ordinance imposing a use tax for general revenue purposes at the rate of two percent (2%) pursuant to the authority granted by and subject to the provisions of Sections 144.600 through 144.761 RSMo; providing for the use tax to be repealed, reduced or raised in the same amount as any city sales tax is repealed, reduced or raised; and providing for submission of the proposal to the qualified voters of the city for their approval at the General Municipal Election called and to be held in the city on April 3, 2018. (Passage of this bill would authorize an April 3, 2018 municipal election ballot measure for voters to consider collection of city use tax based on the point of delivery or out-of-state purchases.)
